- On March 29, 2019, the West Virginia Department of Environmental Protection, Division of Water and Waste Management (hereinafter "Appellee" or "WVDEP") issued a General Permit Registration, No. WVG611874, to the Development Authority for coverage under the West Virginia National Pollutant discharge Elimination System Multi-Sector General Stormwater Permit No. WV0111457 (hereinafter, "Permit").
- 2. On April 29, 2019, Appellant David C. Tabb (hereinafter, "Appellant") certified that he mailed the Notice of Appeal with this Board challenging the WVDEP's issuance of the Permit. The Notice of Appeal was subsequently received and filed by the Board on May 1, 2019.
- 3. WVDEP's issuance of the Permit directly affects the interests of the Development Authority.

- 4. For purposes of an appeal, the procedure and grounds for intervention before this Board are governed by West Virginia CSR §46-4-2.2(e), which provides that in the case of a third party appeal of a permit issued by the WVDEP, the permit holder shall be considered a party in interest and shall have the right to intervene.
- 5. The Development Authority is the permit holder under General Permit Registration No. WVG611874 and is entitled to intervene in this appeal by rule.

WHEREFORE, for the reasons set forth above, the Jefferson County Development Authority respectfully requests that it be granted intervenor status in this matter, and that it be made a party to these proceedings with the right to file and receive all pleadings and other documents in this matter.
