AND EVIDENTIARY HEARING**



In accordance with West Virginia Code §22B-1-7(f), an evidentiary hearing concerning matters as more fully set forth in the Notice of Appeal filed in Appeal No. 17-17-EQB was scheduled for August 9, 2018.

During the July 26, 2018, Prehearing Conference, the parties orally requested a continuance due to a scheduling conflict with Appellant’s counsel. Finding it proper to do so, the Board grants the request for a continuance. The evidentiary hearing in Appeal No. 17-17-EQB shall be continued until the **November 8, 2018**, Board meeting. 
