ORDER GRANTING JOINT MOTION FOR CONTINUANCE


Appeal No. 17-17-EQB was filed with the West Virginia Environmental Quality Board (“Board”) on December 18, 2017. In accordance with West Virginia Code §22B-1-7(f), an evidentiary hearing concerning matters as more fully set forth in the Notice of Appeal filed in Appeal No. 17-17-EQB was scheduled for November 9, 2018.

During the October 25, 2018, Prehearing Conference, the parties requested a continuance to further engage in settlement negotiations which may resolve this matter. Finding it proper to do so, the Board grants the request for a continuance. The evidentiary hearing in Appeal No. 17-17-EQB shall be continued until the **January 10, 2019**, Board meeting.
