At a prehearing conference on September 26, 2024, it was represented that issuance of the permit modification in Appeal No. 21-06-EQB, which has now been finalized and issued to Appellant, will inform the issues set forth in the above-styled appeal and accordingly, a permit modification application is being developed for the instant appeal. Therefore, a continuance of the evidentiary hearing has been requested to allow sufficient time for said permit modification application to be submitted.

Based on the representations of the parties, the Board does hereby order that the evidentiary hearing in Appeal No. 21-06-EQB shall be continued until the **November 14-15, 2024, Board meeting at 8:30 a.m.** Said hearing will be held via Zoom only.
