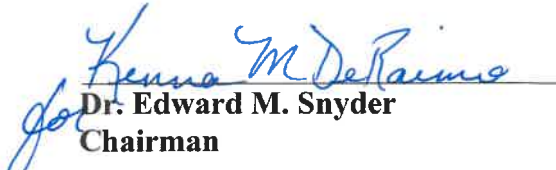
ORDER FOR CONTINUANCE AND NOTICE OF HEARING
