ORDER GRANTING JOINT MOTION TO CONTINUE

Appeal No. 25-06-EQB was filed with the West Virginia Environmental Quality Board (“Board”) on May 28, 2025. Pursuant to West Virginia Code § 22B-1-7(f), an evidentiary hearing was scheduled for November 13, 2025.


During the October 23, 2025, prehearing conference for this matter, the Parties indicated that settlement negotiations were ongoing, and on November 3, 2025, the parties informed the Board, via electronic correspondence, that an additional continuance of this matter is necessary to allow those settlement discussions to further progress. The Parties seek a thirty (30) day continuance to continue those settlement negotiations. The Parties assert that this additional time is necessary to allow for final negotiations and the preparation of settlement documents, if such an agreed resolution can be reached. Finding it proper to do so, this Board hereby GRANTS the Joint Motion to Continue for a period of thirty (30) days.

The evidentiary hearing in Appeal No. 25-06-EQB shall be held on December 11, 2025. Said hearing will begin at **8:30 a.m.** at the Board’s offices located at 601 57th Street, Charleston, Kanawha County, West Virginia 25304. The Parties can participate in person or via Zoom by using
