

MINUTES - MEETING - STATE WATER RESOURCES BOARD - MAY 27 & 28, 1980

The State Water Resources Board met in their conference room located at 1205 Greenbrier Street on the above date at approximately 0830 hours. Purpose of the meeting was to discuss with the Consultant for the New River Company the model treatment plant (or pilot plant) he had constructed to treat New River Company's Price Hill discharge.

Mr. Frank Gatty, Mining Engineer was questioned intensively by Mr. Willard Sullivan and Mr. Robert Pollitt, Attorneys and he also entertained inquiries put to him by the Board members.

After much discussion, a motion was made to extend the New River Company's request for an additional stay -- not to exceed a period of six (6) months--will expire November 30, 1980. (motion voted on - motion carried) Mr. Sullivan is to prepare an ORDER to this effect and send it to the Board office.

Also discussed was the contract of Prof. Pat McGinley -- the Board members unanimously agreed that the payment yet due him should be paid in full as soon as possible (Mr. Kirkpatrick made the motion - Mr. George seconded - motion carried).

Transcripts of the Borgman Coal Co. - Appeal No. 103 which was formally dismissed on this date along with the transcript of Appalachian Timber Services, Inc. Appeal No. 126 will be sent to the Board members upon receipt in this office.

Board members were given a rough Proposed Draft of the Administrative Regs. for Water Quality for comments, changes, etc. to be made - a meeting will be held on June 6th at 1:00 p. m. to go over them before shipping them to the print shop.

Board members present were: John C. Ailes, Chairman, and members Mr. Larry George, Mr. Forrest H. Kirkpatrick and Dr. Edward H. Crum.
